## COVID-19 protective measures

A Contingency Plan has been designed and implemented to ensure that:

- Proper safety measures are in place to guarantee the health of our guests.
- Our premises, staff, and service procedures are in line with the best practices designed to confront the virus.

Our lodging facilities and services have been modified to ensure your maximum safety:



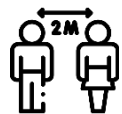
We have reduced the need for direct human contact offering online check-in and payments, email billing, and other services.



We will arrange for the guests to arrive on a staggered schedule to avoid crowding in the reception area.



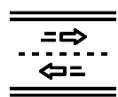
We have removed certain decorative elements to minimise the spread of the virus and to be able to maintain safe distances in common areas.

Our lodging facilities and services have been modified to ensure your maximum safety:



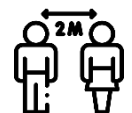
We have placed directional floor markings on stairs, in corridors, and in all common areas.
